PREPAYMENT

If the citation is marked "payable", find the cited offense code(s) and/or the "mph over" for which you were speeding on the reverse side of this form. **Insert the specified amount for each offense in the payment calculation box below. Complete the calculation to determine your TOTAL payment.** If the offense code is not listed and the citation is marked "payable", contact the District Court. **Mailed payments** should be in the form of certified check or money order **made payable to the District Court Clerk** listed below. **DO NOT** send cash through the mail. **Payments made in person** may be made in the form of cash, personal check, certified check or money order.

PLEA OF NOT GUILTY

If you wish to plead not guilty, appear in court on the date listed on your citation.

STATE TRAFFIC SCHOOL

If you have a valid drivers' license and have **NOT** been assigned to STATE TRAFFIC SCHOOL in the last twelve (12) months, you may be eligible. If STATE TRAFFIC SCHOOL is ordered, **you will be billed an additional fee by the school at a later date.** **To request STATE TRAFFIC SCHOOL:** Contact the District Court Clerk. If you are allowed to attend state traffic school you will be required to pay court costs of \$138.00 **BEFORE YOUR COURT DATE.** The address on your driver's license **MUST BE CORRECT.**

EQUIPMENT/LICENSE/REGISTRATION/INSURANCE VIOLATIONS

You may present proof as specified below to the district court clerk OR county attorney. PROOF MUST BE PRESENTED BEFORE YOUR COURT DATE.

- If cited for equipment violation listed on reverse side of this sheet, you may provide proof of repair or you may prepay your fine(s), fees and costs as calculated below.
- If cited for offense code **0435**, you may provide proof of a valid drivers' license.
- If cited for offense codes **0405, 0407, 0424 or 0427**, you may provide a copy of your new registration.
- If cited for offense code **0436**, go to your local drivers' license office, have the appropriate information changed, then provide your new license.
- If cited for offense code **0480**, you may provide your insurance card (with beginning and ending effective dates), or a letter from your insurance company verifying you had insurance PRIOR to the date of your citation. If you did not have insurance in effect you **MUST** appear in court on your court date.

*** IF YOU ARE CITED FOR 02304 OR 02305, CONTACT THE CIRCUIT CLERKS OFFICE FOR THE PROPER PAYMENT AMOUNT.

NOTE: YOU MUST ADD COURT COSTS TO YOUR FINES/FEES FOR THE PROPER PAYMENT AMOUNT UNLESS YOU ARE ONLY CITED FOR 00580, 00499 OR PARKING IN A HANDICAPPED PARKING ZONE. A PAYMENT CALCULATION BOX HAS BEEN PROVIDED ON THE REVERSE SIDE FOR EASE IN DETERMINING YOUR TOTAL PAYMENT. FAILURE TO PAY THE TOTAL AMOUNT MAY RESULT IN LICENSE SUSPENSION.

NOTE: IF YOU ARE CITED FOR SPEEDING OR SPEEDING ON A LIMITED ACCESS HIGHWAY, LOOK TO THE "MINIMUM FINE" AND "MPH OVER" FOR WHICH YOU WERE CITED FOR THE CORRECT FINE/FEES. IF YOU ARE CITED FOR SPEEDING IN A HIGHWAY WORK ZONE, LOOK TO THE "HWZ FINE/FEES" AND THE "MPH OVER" FOR WHICH YOU WERE CITED FOR THE CORRECT FINE/FEES.

IF YOU ARE CITED WITH MULTIPLE CHARGES YOU SHOULD CONTACT THE DISTRICT/CIRCUIT COURT CLERK FOR THE CORRECT FINE/FEES.
