**WHEREAS**, Oldham County Fiscal Court adopted ORDINANCE NO. KOC 16-410-76 relating to the sale of alcoholic beverages in Oldham County.

**WHEREAS**, ARTICLE XXI of such Ordinance regarding a REGULATORY LICENSE FEE states as follows:

(1) Pursuant to KRS 243.075, there is hereby imposed a license fee and a regulatory fee on the gross receipts of sale of alcoholic beverages of each license issued by the ABC Administrator. Said license fee and regulatory fee shall be set by Resolution of Oldham County Fiscal Court and be available from the County ABC Administrator.

**NOW, THEREFORE, BE IT RESOLVED** that Oldham County Fiscal Court hereby sets a license fee for the sale of alcoholic beverages as follows:

The fee for each of the first five (5) supplemental bar licenses shall be the same as the fee for the primary drink license. There shall be no charge for each supplemental license issued in excess of five (5) to the same licensee at the same premises.

**FURTHER, BE IT RESOLVED**, that Oldham County Fiscal Court hereby sets a regulatory fee on the gross receipts of the sale of alcoholic beverages of each license issued by the ABC


Administrator as follows:

**The regulatory license fee shall be five percent (5%) of gross sales of all alcoholic beverages sold by the drink, paid quarterly.**

**The regulatory license fee shall be five percent (5%) of gross sales for all retail package distilled spirits and wine, paid quarterly.**


**The regulatory license fee shall be five percent (5%) on gross retail sales of package malt beverages, paid quarterly.**
